Net Worth as at 1 April 2023 was £550.0m. No Restricted Payments were made in Q2 or during the Relevant Year. The Restricted Payment Maximum at 1 April 2023 was £37.9m and no calculation of the Further Restricted Payment Maximum was required.



Maintenance and Capital Enhancement

The cumulative Maintenance Expenditure in the Relevant Year was £25.9m and the Relevant Period was £14.0m. The Required Maintenance Amount for the Relevant Year was £16.3m.

Capital Enhancement Expenditure of £9.0m was made in Q2, £19.6m in the Relevant Year and £10.6m in the Relevant Period.
